

Democrats Stole the 2020 Election in 8 Ways

1. **VOTER REGISTRATION FORMS** Through the collective effort of many different resources, the entire State of Wisconsin was flooded with **Voter Registration Request Forms**. These forms were sent to as many of the 7.2 million names on the My Vote WI voter roll as possible while looking official and included instructions with a return envelope even if the voter was possibly deceased (See attached Voter Registration 1 and WEC Voter Rolls). A conservative estimate is that hundreds of thousands, if not millions, of these Voter Registration Request Forms were mailed to Wisconsin addresses in 2020 even if they weren't requested.
2. **ABSENTEE BALLOT REQUEST FORMS** Through the collective efforts of many different resources, the entire State of Wisconsin was flooded with **Absentee Ballot Request Forms**. These forms were sent to as many of the 7.2 million names on the My Vote WI voter roll as possible with the attached example being from the **Wisconsin Elections Commission (WEC)** including a return envelope (See attached Absentee Ballot Request Form 1 and WEC Voter Rolls). A conservative estimate is that millions of these Absentee Ballot Request Forms were mailed to Wisconsin addresses in 2020 even if they weren't requested. According to WEC, there were **2 million absentee voters** in Wisconsin in 2020 with a **minuscule rejection rate of .002% or 4,270 rejected ballots statewide** when the normal ballot rejection percentage rate is 2-3% (See attached WEC Page 12). Absentee ballots were strongly encouraged because of covid. The photo ID requirement is more of a challenge for Clerks when voting absentee. According to WEC, some **86,000 absentee ballots were never returned in 2020**. So many of the absentee ballots were purposely delivered at the last possible minute to overwhelm Clerks in hopes that the signature and address requirements would not be questioned so that ballots could be processed.
3. **NURSING HOME RESIDENTS** normally request a ballot through the **Special Voting Deputy Election Law**. That law was not followed by Clerks in 2020 due to WEC's Guidelines involving covid concerns. On any given day during the 2020 Election, some **92,000 residents** lived in some 1,121 long-term care facilities in Wisconsin. Justice Gableman's March 1, 2022, Interim Election Fraud Investigation Report, documents massive election fraud in these nursing homes (See attached Gableman Report Page 81).
4. **EARLY IN-PERSON VOTING** Voters were strongly encouraged to vote **early in-person** due to covid. These voters are lumped in with absentee ballots (See attached WEC Page 12). Voter ID was enforced for voting in-person.
5. **INDEFINITELY CONFINED VOTERS** The **Dane and Milwaukee County Clerks** [story here](#) strongly encouraged Wisconsin voters to declare themselves "**indefinitely confined**" in 2020 due to covid without having to show photo ID. Wisconsin election law is very specific about what it takes to be declared indefinitely confined. Indefinitely confined voter rolls swelled from about **66,000 to 267,000** in 2020, according to WEC, and almost all of them voted in 2020 [story here](#).

6. **ERIC's MOVER LIST**, a contracted vendor with WEC that was founded and funded by George Soros and has WEC Director Meagan Wolfe as its Board Chairman, is supposed to track Wisconsin voters that move out of Wisconsin and are therefore ineligible to vote. Some **232,000 of ERIC's Mover List voters** were left on WEC's Voter Roll in 2020 with some **69,000** of them voting in the 2020 Presidential Election because the democrats sued to have them remain eligible to vote through the Wisconsin Supreme Court. 7. **ILLEGAL BALLOT DROP BOXES** True the Vote (www.truethethevote.org), revealed on March 1, 2022 before the Assembly Campaign and Elections Committee, through geo-spatial technology analysis, that a sampling of some of Wisconsin's 573 illegal ballot drop boxes had a minimum of 137,551 illegal ballots illegally deposited into them well after midnight and before 5:00 A.M. by paid ballot harvesting mules associated with non-governmental organizations during the 2020 Election.
