On 12/2/22 at 3:32pm Principal Dave Elliott of the Cornell High School emailed me a referral for possession of a vape pen on high school property. In his report he said the vape fell out of the hoodie of [REDACTED], who confessed to possessing it.

On 12/5/22 I telephoned Shelly Valentine, [REDACTED] mother. She said [REDACTED] doesn't smoke but she believes he was holding it for a smoker. However, she said [REDACTED] was unwilling to name the person or provide more information, though she believed he (and his honor system) were being used by the person for whom [REDACTED] was holding the vape. She took my name and number and said she would call if [REDACTED] was willing to provide more information.

I prepared, issued, and mailed a citation for the offense. I also mailed a parent notification letter to Valentine.

Case closed.
