Narratives

Original Narrative

12/16/2022 02:41:36

On 12/9/2022, I was dispatched to a fight at the Cornell High School. I was told by dispatch that a few members of the Cornell Boys Basketball team had started fighting and one player had choked another player. I left my current call and responded to the Cornell High School emergent. I entered the school through the cafeteria doors and saw a large group of people in the cafeteria area.

Contact with Glenda Rablin

I was approached by Glenda Rablin, who told me that one of the Cornell players became very upset after losing the basketball game and he punched the door leading out of the gym. Glenda told me the boy's name was Dawson Munson. Glenda said that Dawson was then approached by teammate and was told to chill out. Glenda told me that a fight started between the boys in which Dawson was seen choking the teammate. Glenda told me that Dawson was upstairs in a classroom cooling off and led me to him. As we walked into the stairwell just off the cafeteria I noticed the entire Cornell Basketball team waiting in the stairwell.

Contact with Dawson Munson and Cornell Basketball Assistant Coach Jake Hall

I contacted Dawson and Jake in the classroom on the next floor just left of the stairwell. Dawson was visually upset and sitting on a desk. I asked Dawson if he could gather his things and speak with me in the hallway. I spoke with Dawson and Jake in the hallway. Dawson told me that he was 18 years old. I asked Dawson what happened, but he was reluctant to speak with me or answer questions. Dawson told me that he was involved in a fight with Avery Turany. Dawson stated emotions were high after the game and he lost his temper. Dawson mentioned that he has a hard time controlling his emotions at times and stated that he handled the situation better this time more than last time. I told Dawson that I was informed that he "choked" his teammate. Dawson looked down and acknowledged that it happened by nodding his head in a yes motion. Dawson told me that [REDACTED] was there and saw what happened. Jake told me that Dawson had committed a foul in the game which caused Cornell to lose. Jake stated that Dawson took the loss hard and acted the way he did. Jake told me that he did not see the fight.

Jake mentioned that he has been trying to help Dawson control his emotions. It appeared to me that Jake is attempting to be a positive mentor to Dawson

Contact with Avery and Teresa Turany

I made contact with Avery (18) and his mother, Teresa, down the hall from Dawson. Avery told me he was not playing in the game due to an injury. Avery told me that Dawson often gets overcome with emotions and has a troubled history of dealing with them. Avery told me that Dawson punched the door and started to make a scene after the game. Avery told me that he confronted Dawson about his actions, which led to Dawson pushing Avery against the wall by his neck. I asked Avery to show me how Dawson was choking him. Avery placed his thumbs over top of each other and formed a "U" shape with his hands. Avery then placed his hands up to his neck. Avery consented to me looking at his neck. I did not notice any signs of redness or markings. Avery told me that the choking did not impede his breathing. Avery told me that he did not wish to pursue charges against Dawson. Avery stated that everyone's emotions were high after the tough loss. Teresa also mentioned that she did not think charges were appropriate.

Contact with [REDACTED] and Ben Modl

I spoke with [REDACTED] with his father, Ben, present. [REDACTED] told me that he did not see the events that took place. He had only heard that Dawson had choked Avery. [REDACTED] did mention that Dawson has trouble controlling his emotions.

Re-Contact with Dawson and Jake

I told Dawson that I had probable cause to believe that he choked Avery. I also informed him that Avery did not want to pursue charges. I told Dawson that I would be continuing to investigate the matter. I told Dawson that he would be hearing from me as he could be cited for Disorderly Conduct. Jake and I spoke with Dawson about possible counseling services that might be available, as he is also a student at CVTC in Eau Claire. Dawson was informed that he could contact Student Services with CVTC as they have a wide range of programs to assist students. I confirmed with Dawson that he had a ride home after the game. I collected contact information from him and Jake.

Contact with Jake Hall

I spoke with Jake independently.

Jake told me that Dawson has come a long way since he started assisting him.

Jake told me that Dawson has a strong distrust for police, which was evident in my interaction with Dawson. Jake asked me if I knew of any resources around that could help him with Dawson. I told Jake that I believed the services we suggested to Dawson were as much as I could locate. I told Jake that since Dawson was 18 he would have to come speak with me about the issues at home. Jake stated that he was aware and will continue to encourage that with Dawson.

I cleared from the scene.

Nothing further at this time, pending review of stairwell cameras.
