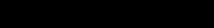

### Supplemental Narrative **09/25/2024 23:13:15** **Andrew Holty**

On Wednesday, September 25, 2024, at approximately 2049hrs, I, Officer Andrew Holty with Stanley Police Department, made telephone contact with Erik Carlson after he contacted the Chippewa County Sheriff's Office to report an incident that occurred earlier in the evening (around 1815hrs) with his stepson [REDACTED] (D.H.) at the Stanley-Boyd High School.

Erik advised that D.H. was waiting in the parking lot after practice for his ride home from the school. Erik indicated that the week previous, D.H. and another student had a verbal/physical altercation that had to be separated by school staff. Erik stated that D.H. made a comment to the another student [REDACTED] (J.R.) similar to "do you have your Green card." D.H. apparently made a remark about J.R.'s mother to which J.R. advised D.H. that his mother had just recently passed away, which apparently made matters worse.

Tonight, as D.H. was waiting for a ride, he explained to Erik that J.R.'s 19 year old brother was waiting for him in the parking lot. Erik advised that another student made D.H. aware that this male was waiting for him so he exited the north doors of the school instead and waited on that side of the school. According to what Erik learned from D.H., other juveniles at the school notified the subject of his location at the north doors. D.H. asked a teacher, who happened to be leaving at this time, for a ride home to avoid the brother and what he believed was going to be a violent altercation.

Erik advised that the school handled the incident last week in-house, but he and his wife (Penny Carlson) were concerned that this was not going away and had concern for his safety.

Stanley-Boyd High School Principal (Tanya Mahr) was made aware of the incident and advised he would be reviewing the school's security system the following day (9/26/2024) to gather more information.

I advised Erik that I would pass on the information to the day shift officer to follow-up on the matter. I also informed him that I would attempt to follow-up with him the next day once more was learned. Erik advised that he will be keeping D.H. home the next day to avoid any further issues. He hoped that parents and the juveniles could come together to work this out and make things right.

The following day Chief Weiland spoke with Mrs. Mahr and learned that the other subjects at the school that evening were Jordan Booth (18) and Christian Ruiz (18), who is the brother to J.R. Principal Mahr learned that nothing physical occurred at the school, but she contacted Jordan and Christian and advised them that for the foreseeable future they were not welcome at the school. Jordan advised Principal Mahr that they were at the school to work out.

Based on the situation, it is believed that Jordan and Christian responded to the school that evening to confront D.H. about what was said to J.R..

Principal Mahr advised that she would be having both juveniles meet at school to talk about what occurred and how they could move ahead without any further issues. I was advised that Karen Gadke was the guardian for J.R. at this time.

I attempted telephone contact with Erik and Penny but was unable to speak with anyone.

At this time, Principal Mahr is not requesting any further assistance from the Stanley Police Department regarding this matter. This is all the information I have at this time. Holty - 248
